

**PROPERTY OWNER'S CONSENT TO ENTER UPON AND REMOVE

**I DO HEREBY, FOR MYSELF, MY HEIRS, EXECUTORS, AND ADMINISTRATORS, RELEASE, ACQUIT, RELINQUISH AND FOREVER DISCHARGE THE CITY, AND ALL OF THE CITY'S OFFICERS, COUNCIL MEMBERS, AGENTS, REPRESENTATIVES AND EMPLOYEES FROM ANY AND ALL DEMANDS, CLAIMS, DAMAGES, OR CAUSES OF ACTION OF ANY KIND WHATSOEVER RELATED TO THE CITY'S ENTRY ONTO THE PROPERTY, AND THE REMOVAL AND DISPOSAL OF THE MOTOR VEHICLE, THAT I HAVE OR MAY HAVE IN THE FUTURE, INCLUDING, BUT NOT LIMITED TO, BREACH OF CONTRACT, QUANTUM MERUIT, CLAIMS UNDER THE DUE PROCESS AND TAKINGS CLAUSES OF THE TEXAS AND UNITED STATES CONSTITUTIONS, TORT CLAIMS, THE CITY'S NEGLIGENCE, PERSONAL INJURIES OR PROPERTY DAMAGE.**
